

<p>Pursuant to Article 13 and Article 14 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (hereinafter "GDPR"), we would like to inform you as follows:</p>

<p>III. Objectives and basis of processing</p>	<p>Your data is processed:</p> <ol style="list-style-type: none"> 1. in connection with your participation in the "Innovations in the PGE Capital Group" Programme - based on your consent for personal data processing (Article 6 Clause 1 Letter a of the GDPR); <p>By sending a form with a proposed innovation, you confirm your participation in the programme and also your consent for the processing of your data in a personal data form.</p> <ol style="list-style-type: none"> 2. for the purpose of establishing cooperation with respect to proposed innovations or pre-contractual activities (Article 6 Clause 1 Letter f of the GDPR); 3. for the purpose of establishing, pursuing or defending claims constituting the safeguarding of a legitimate interest of the Data Controller (Article 6 Clause 1 Letter f of the GDPR).
<p>IV. Consent and right of withdrawal</p>	<p>You have the right to withdraw your consent at any time if your data is processed on the basis of this consent. The withdrawal of your consent does not affect the lawfulness of data processing that has been carried out on the basis of the consent before its withdrawal. <p>V. Categories of processed data</p>	<p>Data provided in the application form.</p> <p>Basic Data/Identification Data (e.g., name, telephone number, e-mail address, name of Applicant or Organization).</p>
<p>VI. Source of data</p>	<p>The personal data were obtained directly from you or from the person you represent.</p>
<p>VII. Data retention period</p>	<p>The period of processing of your personal data is related to the purposes of processing indicated above. In view of the above, personal data will be processed for the time when the provisions of the law oblige the Controller to store the data or for the period of limitation of possible claims the pursuit of which requires the availability of such data (no longer than 6 years from the date of termination of the contract/cooperation).</p>
<p>VIII. Data recipients</p>	<p>Your personal data will be transferred to authorized institutions specified in the applicable legal regulations and to processors who provide services for the Data Controller and to whom the data is entrusted.</p>

	<p>Personal data may be transferred to:</p> <ol style="list-style-type: none"> 1. institutions specified by the legal regulations, e.g. the Tax Office, the Social Insurance Institution, the State Labour Inspection, insurance companies, legal and audit firms; 2. the companies belonging to the PGE Capital Group, our partners, i.e. companies with which we cooperate by combining products or services; 3. subcontractors and service providers (data processors), e.g. PGE Systemy.
IX. Processing of data outside the EEA	<p>As a rule, your personal data will not be transferred outside the European Economic Area (EEA). However, taking into consideration the maintenance of the IT infrastructure and the services provided by the company PGE Systemy S.A. in the capacity of a data processor, whose selected subcontractors operate outside the EEA, your personal data may be transferred outside the EEA. Each transfer of personal data has a legal basis resulting from Article 46(2) of the GDPR.</p>
X. Rights of the data subject	<p>According to the GDPR, you are entitled:</p> <ol style="list-style-type: none"> a) to access your data and receive its copy; b) to correct your data; c) to remove your data, restrict its processing, or file an objection against its processing; d) to transfer your data; e) to lodge a complaint with the supervisory authority - President of the Office for Personal Data Protection, 00-193 Warsaw, Stawki 2 Street. XI. Right to object	<p>You have the right at any time to file an objection against the processing of your data for the purpose and on the basis as indicated above. The Controller will cease processing the data for these purposes unless it can demonstrate that there are compelling legitimate grounds which take precedence over your interests, rights, and freedoms or that the data will be necessary for the establishment, pursuit or defence of claims. XII. Information on the voluntary provision of data	<p>In the case of obtaining personal data directly from you, providing personal data is voluntary, however, failure to do so will prevent you from fulfilling the purposes indicated in pt. III above.</p>
XIII. Automated decision making and profiling	<p>We will not use your data in automated decision making and profiling processes.</p>
